TECHNICAL INFORMATION

BASE

Aluminium painted in pewter colour set on plastic floor slides.

SEAT (SOFAS AND POUF)

Internal structure is a solid firwood (Picea abies) frame and chipboard, with elastic straps. Padding in variable density high-resistance foam polyurethane. Light velvet cover.

BACKREST (MODELS WITH LOW BACKREST)

Internal structure in Polimex (a composite polyester/polyurethane material) covered with high performance variable density polyurethane foam. Cover in bonded velveteen.

BACKREST (MODELS WITH HIGH BACKREST)

Metal frame with elastic bands. Flexible cold moulded polyurethane foam. Cover in bonded velveteen with resin coated side.


